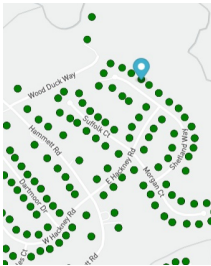
We hope you have a safe and enjoyable holiday weekend.

The [FCC National Broadband Map](#) displays addresses where high speed internet services are available across the United States, as reported by Internet Service Providers (ISPs) to the FCC.



The map will be updated continuously to improve its accuracy through a combination of FCC verification efforts, new data from internet providers, updates to the location data, and information from the public.

This information will be important to appraisers with the release of the new UAD 3.6.
