Introducing the New UAD 3.6 Public Preview Dynamic Report



The wait is over—UAD 3.6 dynamic reports are here! Lenders, appraisers, demo customers, and all industry professionals can now access the UAD 3.6 Public Preview from SFREP. This

preview is open to anyone and everyone!

Released on September 8th, this is the first of several updates planned through 2026. According to the GSE timeline, UAD 3.6 reports will be accepted by GSE-approved lenders starting September 8th and will become mandatory on November 2, 2026.

Later this month or in early October, we will release the first public beta version of Appraise-It Pro with full UAD 3.6 report capability, including:

- MISMO 3.6 export
- UAD Compliance API integration
- Street Maps integration
- Sketching integration
- Help Text

To help you get started, sample reports based on GSE scenarios are available in Documents\My Appraise-It\Data\Samples.

More documentation and videos are on the way. To add the new UAD 3.6 reports to your forms library in Appraise-It Pro, go to Support > Check for Updates. Start exploring now to get comfortable with the new dynamic report format.

Lenders and UAD 3.6 **Progress Is Being Made**

The timeline is set for lenders to accept UAD 3.6 alongside current UAD 2.6 reports during the Limited Production Period of September 8, 2025 - January 25, 2026. Initially, we



expect a slow rollout of lender requests for UAD 3.6. It has been reported that a few lenders plan to accept UAD 3.6 appraisals starting in October 2025.

Work is underway by lenders to complete a questionnaire and receive approval from the GSEs to submit UAD 3.6 reports. The transition requires a comprehensive review of all systems that touch the valuation process to ensure they can handle the new data. We recommend contacting your lender to verify their schedule.

At SFREP, we are confident that we will be able to release our first UAD 3.6 Public Beta version that will allow users to deliver a completed UAD 3.6 report by early October.

The UAD 3.6 Preview, released on September 8th, was an excellent opportunity to begin your review. This should allow you plenty of time for a reasonable transition by the time your lender requests it.
