UAD 3.6 Reports Are Being Submitted, Accepted, and Approved

Currently UAD 3.6 appraisal reports created by Appraise-It Pro are being successfully submitted, accepted, and approved. Our Public Beta version is available to all appraisers as existing or demo customers. Users can now accept, produce, and deliver UAD 3.6 reports to clients. As a reminder the acceptance [timeline](#) is set. Dates are as follows:

September 8, 2025 – Limited Production
Fannie Mae and Freddie Mac accept both UAD 2.6 and 3.6 from lenders who have submitted the UAD questionnaire and received GSE approval.

January 26, 2026 – Broad Production
All lenders may begin submitting to the GSEs' production environment without prior GSE approval.

November 2, 2026 – UAD 3.6 Mandate
Lenders must use UAD 3.6 for all new submissions on or after this date. Revisions allowed for previously submitted UAD 2.6 appraisals.

May 3, 2027 – UAD 2.6 Retired
UAD 2.6 Pipeline revisions period ends.
